- 3. The Pickers Paradise fundraiser is scheduled for Saturday, August 6<sup>th</sup>. Flyers and invitations are available in the narthex. Money raised from the sale of the parking lot spots will fund the new K-8 language arts curriculum.
- 4. The new K-8 playground equipment is on-site and ready for set up.
- 5. Plans for the Trinity School 70th anniversary celebration are underway. Linda Klipp is looking for volunteers to brainstorm and assist.
- 6. Four full- time and 11 part-time preschoolers are enrolled in the Summer Camp program.

  includes boys and girls basketball and volleyball.
